- Driven by innovation, security, and community empowerment.



Year 1: Foundation & Utility Activation (2025–2026)

Objective: Establish credibility, secure compliance, build utility & grow early community

1. Launch & Ecosystem Setup

Smart contract audit (by top-tier firms like CertiK, PeckShield)
Public token launch (IDO/ICO)
Listing on top-tier CEXs & DEXs (Uniswap, PancakeSwap)

2. Real-World Use-Case Deployment

Launch ArbittPay for payments in ecommerce, retail (plug-ins for Shopify, WooCommerce) Partnership with 100+ global merchants for Arbitt acceptance Pilot micro-payment support (gaming, music royalties, streaming)

3. Compliance & Legal KYC/AML framework setup

Regulatory sandbox partnerships (e.g., with MAS, FINMA, UAE VARA)

4. Community & Governance


